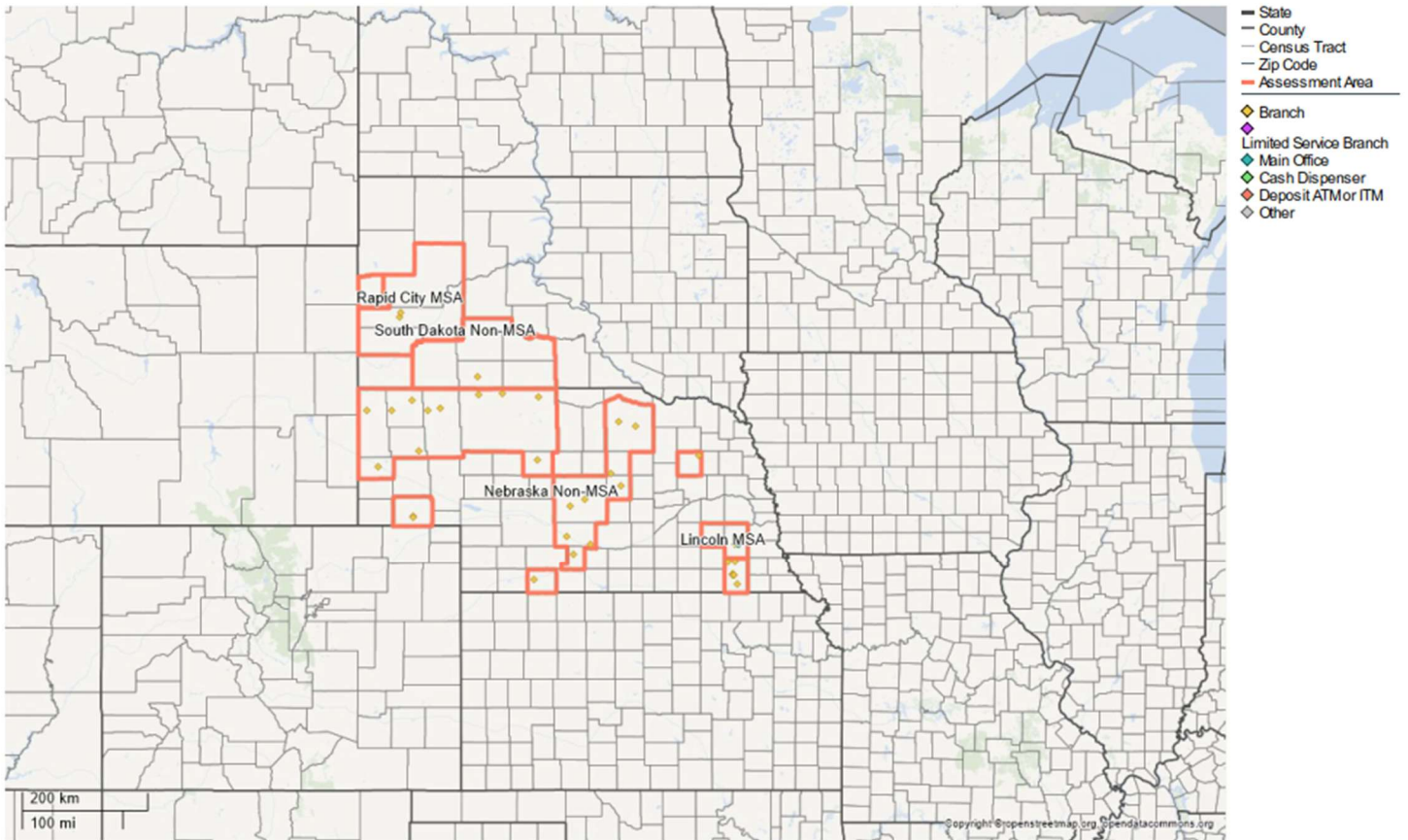


Map of Assessment Area
